

## **Just Energy Group Inc. 2013 Canadian Tax Information**

As a corporation, Just Energy Group Inc. (“JEGI”) makes dividend payments to its shareholders. During 2013, the monthly dividend amount paid by JEGI in each of January, February, and March was Cdn. \$0.10333 per share, and was Cdn. \$0.07 per share in each remaining month of the year .

For the purposes of the Income Tax Act (Canada) and any similar provincial and territorial legislation:

JEGI designated all dividends paid in 2013 as “eligible dividends”. As a consequence, dividends paid by JEGI during this year to Canadian shareholders who hold JEGI shares outside of their tax deferred accounts should qualify for the enhanced dividend tax credit, resulting in an effective tax rate of 16% to 36% for those individuals in the highest marginal tax bracket, depending upon provincial jurisdiction and individual circumstances.

For Canadian investors who hold JEGI shares in tax deferred accounts (i.e. RRSP, RRIF, RESP or DPSP), no amount of the dividends need to be reported in their 2013 T1 Income Tax returns.

The actual taxable amount of dividends paid will be communicated to shareholders via T5 information slips prepared by their brokers. The deadline for mailing 2013 T5s as required by the Canada Revenue Agency is February 28, 2014.
